IMPORTANT INFORMATION:

Permanent Court Time (PCT) is a reservation for the same day and same time each week and is an full indoor season. *They are subject to availability. \$200 deposit is only required if first time booking Permanent Court Time at Eastside.*

- Applications can also be scanned and emailed to Brian@Eastsideclub.com or turned into drop box on office door.
- Each player is **required to have a club membership** for the duration of the PCT session.
- One person will serve as the PCT Captain. That person is responsible for completing and signing the PCT group reservation application and submitting a roster for billing prior to August 15th. All PCT captains will receive a free Eastside membership. If the group is over a 2-court reservation, they will also receive complimentary spot in their reservation.
- **IMPORTANT:** The PCT Captain is the group representative and all communication between the Eastside and the group will be through the Captain. The Captain is responsible for communicating PCT information, schedule, guidelines and procedures to its players. When turning in the roster sheet it is important to write player names along with # times playing for billing purposes, or if just splitting evenly please write accordingly. If a player has a discrepancy with their play time changing, the PCT Captain can notify Brian@EastsideClub.com any changes to the billing and it will be corrected ASAP. It will only be approved if the notification was from the PCT Captain.
- Payment for each session will be due in full at beginning of each session
- Blackout dates are subject to change. Eastside, at its discretion, may cancel scheduled PCT for maintenance, special events, or other reasons. If this happens, court time will be added at the end of the session or a refund will be given.
- PCT reservations are non-transferable.
- PCT reservations may be revoked for violation of PCT rules or club policies.
